## European Directives 2011/65, 2015/863 (ROHS II) and 2012/19 (WEEE)

Directive 2011/65/EU (Restriction of Hazardous Substances) and delegated Directive 2015/863 on the restriction of the use of certain hazardous substances in electrical and electronic equipment establishes permissible maximum concentrations for hazardous substances in homogeneous materials:

- max. 0.1 % by weight for lead, mercury, hexavalent chromium, polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE), and phthalates (DEHP, BBP, DBP, DIBP)
- max. 0.01 % by weight for cadmium.

The above mentioned substances are not intentionally added during the stainless steel production and are consequently not present in stainless steel at all or only as technically unavoidable trace impurities in concentrations below the specified limits.

2012/19/EU (Waste Electrical and Electronic Equipment) on waste electrical and electronic equipment establishes requirements for equipment manufacturers, so this directive is not directly applicable to semi-finished material producers. In any cases, we declare that our products are not materials for which selective treatment is required under 2012/19/EU, Annex VII.

All the products of Acciai Speciali Terni S.p.A. con Unico Socio fully comply with RoHS and WEEE requirements and there are no substances to be declared.
